- Minimum 5 years of experience in international or government institutions and/or projects funded by government or international financial institutions;
- Minimum 3 years of experience in managerial positions;
- Proven track record of good knowledge of donors' policies, procedures, and guidelines on procurement, financial management and safeguards, knowledge of the World Bank policies, procedures and guidelines is an asset (certificate);
- Experience in the road sector, government systems and policies, knowledge of FIDIC, GOST and SNIIP.
Possession of relevant certificates is an asset;
- Fluency in Russian and Kyrgyz. Good knowledge of written and spoken English is an asset;
